Redesigned Burn Pit Registry Helps Ease Veteran Participation & Advance Research

The U.S. Department of Veterans Affairs recently announced the completely redesigned Airborne Hazards and Open Burn Pit Registry (Burn Pit Registry), helping to enable VA executive leaders and researchers with the capability to understand and ultimately improve treatment and care practices for the health challenges Veterans face after exposure to airborne hazards and burn pits during service.

The improved research and data capability of the redesigned Burn Pit Registry does help to better identify and

study health challenges spanning the Veteran and service member population. This, in turn, can lead to improved care and benefits of Veterans and service members. Participation in or opting out of the registry has no impact nor does it determine eligibility for Veterans' individual VA health care or benefits.

groundbreaking research and enabling VA's ability to identify and proactively address health challenges that toxic-exposed Veterans face at a population level," said **Under Secretary** for Health Shereef Elnahal, M.D. "While the registry does not impact an individual Veteran's health care or benefits, it does serve as a catalyst for advancing new and innovative treatments for the Veteran population as a whole — including informing decisions related to presumptive conditions, more precise predictive medicine, and proactive Veteran care. This redesign massively expands the registry and reduces the participation requirements for Veterans, paving the way for critical research in the coming years

Organizations Committed to Providing Employment-Based Resources & Tools Helping Recently Separated Members of the Armed Forces & Their Spouses Eligible for Grants



The VA is set to award approximately \$4 million in grants this year through its new program, the Veteran and Spouse Transitional Assistance Grant Program. Eligible organizations providing

help recently separated members of the Armed Forces and their spouses ease transition from service to civilian life are invited to apply.

According to the VA article <u>here</u>, each grant will be in

increments of up to \$500,000 and is to be matched by the grantee organization.

Priority preference will be given to applicants that either provide multiple services or are in a state with any one of these criteria:

- A high rate of unemployment among Veterans.
- A high rate of usage of unemployment benefits for recently separated members of the Armed Forces.
- A labor force or economy that has been significantly impacted by a covered public health emergency.

The PACT Act and Your VA Benefits

The PACT Act is a law that expands VA health care and benefits for Veterans exposed to burn pits, Agent Orange, and other toxic substances. This law helps us provide generations of Veterans – and their <u>survivors</u> – with the care and benefits they've earned and deserve. And starting March 5, 2024, we're expanding VA health care to millions of Veterans – years earlier than called for by the PACT Act.

This page will help answer your questions about what the PACT Act means for you or your loved ones. You can also call us at 800-698-2411 (TTY: 711). And you can file a claim for PACT Act-related disability compensation or apply for VA health care now.

Enrollment Application for Health Benefits (VA Form 10-10EZ)

VA health care covers care for your physical and mental health. This includes a range of services from checkups to surgeries to home health care. It also includes prescriptions and medical equipment. Here's what you'll need to apply:

- Social Security numbers for you, your spouse (if you're married), and any dependents you may have.
- Insurance card information for all health insurance companies that cover you. This includes any coverage that you get through a spouse or significant other. This also includes Medicare, private insurance, or insurance from your employer.
- Your military service history information and details about exposure to toxins or hazards.
- A copy of your DD214 or other separation documents. If you sign in to apply, we may be able to fill in your military service information for you. If you don't sign in to apply, you can upload a copy of your DD214 or other separation documents.

Did You Know?

- Registry Participation is Voluntary.
- Participation has **no impact** on eligibility for VA health care and benefits.
- No medical information will be stored in the registry.

Many Veterans Who Deployed After 1990 Automatically Added to Registry

Veterans and service members who served in the military campaigns or theater of operations listed below during the designated time frame-based on information from the Department of Defense (DoD) will automatically be included.



- Operations and Campaigns: Desert Shield and Desert Storm; Iraqi Freedom; Enduring Freedom; and New Dawn
- Iraq, Afghanistan, Kuwait, Saudi Arabia, Bahrain, Djibouti, Gulf of Aden, Gulf of Oman, Oman, Qatar, United Arab Emirates, waters of the Persian Gulf, Arabian Sea, Red Sea, Syria, Uzbekistan, and Egypt between Aug. 2, 1990, and Aug. 31, 2021
- Somalia since Aug. 2, 1990
- The Southwest Asia theater of military operations and Egypt any time after Aug. 2, 1990
- Afghanistan, Djibouti, Jordan, Lebanon, Syria, Uzbekistan, or Yemen any time after Sept. 11, 2001
- Associated airspaces with the countries listed above as well as the waters of the Persian Gulf, Arabian Sea, Gulf of Aden, Gulf of Oman, and the Red Sea.

This tool is a significant improvement in making data available in a way that better serves all those who were exposed to burn pits and other hazards," said Department of Defense Assistant Secretary of Defense for Health Affairs Lester Martinez-Lopez, M.D. "Being part of the Registry is a way for individuals to help and improve our understanding of the challenges faced by service members and Veterans affected by these exposures.

How Do I Opt Out?

The data included in the registry includes deployment locations, military personnel information, and demographics to include gender, race, and ethnicity. Again, no medical information will be stored in the registry. Veteran and service member data will be accessible only to select VA epidemiologists and researchers and institutional review board-approved researchers. It will be used to conduct research on the cohort over a period of time. The results will inform the policy decision-making efforts of VA executive leaders, including those related to presumptive conditions.

VA Grants Benefits to 1.1M Veterans & Their Survivors – **An All-Time Record**

The U.S. Department of Veterans Affairs announced that it has granted benefits to 1.1 million Veterans and their survivors, awarding \$137 billion in benefits - including \$127 billion in compensation and pension benefits – as of late July.

The VA processed more than 2 million claims in 2024 (another all-time record) to reach this milestone. The VA also reported that the grant rate for these claims is 64.6% and the average overall disability rating granted to Veterans this year to-date is 70%, equating to over \$20,000

Our goal is to make sure every Veteran and every survivor gets the benefits they've earned for their service to this country," said VA Under Secretary for Benefits Joshua Jacobs. "These Veterans and survivors are now receiving monthly payments for the conditions that followed them home from war or took the lives of their loved ones – and there is nothing, nothing more important than that.

per year in disability compensation.

The VA also stated it is now delivering more care and benefits to Veterans in these ways, as noted in the recent press release here:

- More Veterans are using VA health care. The VA is on pace to deliver approximately 127M health care appointments in 2024, surpassing last year's record of 120M appointments.
- More Veterans are enrolling in VA health care. 412,867 Veterans have enrolled in VA care over the last 365 days, an increase of 27% year over year — and the most since 2017.
- More Veterans are applying for VA benefits than ever before.

Due to the largest outreach campaign in VA history, Veterans submitted 2,433,729 claims applications in 2023 - an all-time record and 39% more than in 2022.

- More Veterans report trusting VA. • Veteran trust in VA has reached an alltime high of 80.4% – up from 55% when the survey began in 2016.
- When Veterans apply for benefits, they are more likely to have their claims granted.

The VA goal is to work with Veterans to gather evidence to get a yes - whenever a Veteran applies for benefits. Due to this approach, the VA has been able to grant benefits for 64.6% of claims, including 75% of PACT Act related claims, a sharp increase from previous years. \star
